- Payment will be made by email transfer to pddastaff@gmail.com, cash or cheque to hold your spot. Spots will NOT be held in class until payment is made according to the payment option you chose when registering.
- In the event of a Federal/Provincial/Local Government Lockdown classes will be moved online to Zoom.
- Refunds or credits will not be issued if you choose to not participate in the online Zoom classes if we are forced into that by Federal and/or Provincial and/or Local Government or health unit authorities.
- If you register for a class, hold a spot with payment & then you decide for your child or you to not attend classes, whether it be before classes have begun or once classes have begun, NO FORM of refund or credit will be issued because you changed your mind.
- When registering for full season weekly classes - September through April, you agree to pay the costume fee per class stated on the fee page of the Port Dover Dance Academy website. Costumes are ordered in early November each season to ensure delivery on time. Room for students body growth will be considered. All costume sales are final with no option for refund, credit or exchange.
- Pre-school class students (3 years) will walk into the waiting room with a parent for drop off. Then the parent agrees to leave the studio waiting room during class & return to the waiting room for pick up at the end of class.
- Students in Mini classes and above (jk/sk/Gr1 & above) are required to enter the waiting room on their own. Parents walk them to the door, wait outside during class & return to the door for pick up at the end of class. Our waiting room is small, this not only helps with congestion, as well as; your child will independently get themselves ready while gaining self-confidence.
- Please send your child already dressed in their dancewear with only dance shoes & a full water bottle.
- I agree to follow any/all policies/guidelines/rules that are given by the federal/provincial/local government if we find ourselves in any form of public health situation.
- If I do not agree with any/all policies/guidelines/rules that are given by the federal/provincial/local government I agree to stop attending classes with no form of credit or refund for fees paid.
- I hereby consent to having the student(s) named on the registration form receive dance instruction from the Port Dover Dance Academy.
